Re: Hiring of Two (2) Officers, Patrol Division
Ms. Natasha K. Hindman

As you are aware, the Indian Shores Police Department has been under-staffed for over a year as seven (7) Officers have left the department for various reasons. (retired, transferred to another agency, terminated, etc.) This has caused current Officers to work long hours to maintain the service levels the Public expects, and at great expense as evident in the ending FY16/17 budget. To date, this is already causing a negative impact on the FY17/18 budget.

To reverse this negative impact, and with due-diligence. I ask approval to hire two Officers for the Patrol Division.

Ms. Natasha Hindman comes to us from the St. Petersburg Police Department. She has all the certifications and training needed to be a “certified” Law Enforcement Officer pursuant Florida State Statutes. Her current employment with the Manatee Children Services is a valued asset, plus she will add diversity to the I.S.P.D. Natasha will be assigned to the Patrol Division and will report to Deputy Chief, Major Smoak for assignment. *Please see her resume’ synopsis for more detailed information. (attachment)*

Mr. Justin Guillory was recently with the Gulfport Police Department. He also has all the certifications and training needed to be a “certified” Law Enforcement Officer pursuant Florida State Statutes. Justin attended Rasmussen College where he earned an Associates Degree in Criminal Justice, which is also a valued asset to the department. He will be assigned to the Patrol Division, and will report to Deputy Chief, Major Smoak for Assignment. *Please see his resume’ synopsis for further detailed information. (attachment)*

The hiring of both Officers will have a negative impact on the FY17/18 budget. However, as stated in a Memorandum dated 30 October, 2017 *(attached)*, this is an effort to minimize said impact with the projected savings in “Personal Services/Police, and Overtime.” Which will in turn raise the standards of Police Services given to our Citizens.

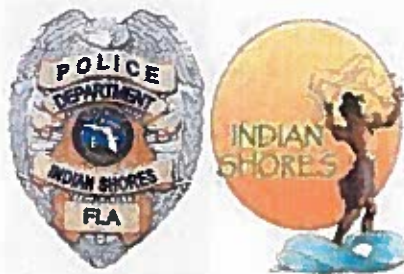

Re: Hiring of one (1) Additional Officer

The Indian Shores Police Department is currently at a minimal staffing level, which means every shift is covered. However, if an Officer calls out sick, on annual leave, or out to take advance training classes. * The department is forced to use Part-Time Officers or Full-Time Officers (at over-time rates) to cover the shift.

In an effort to minimize the strain on the FY17/18 budget in areas of "Personal Services/Police", "Overtime", and to raise the standards of Police Services given to our Citizens. I ask approval to hire an additional Officer for the Patrol Division.

This Officer will work adverse shifts to fill in when other Officers are out as stated above, or be assigned to specific duties as the department sees fit. There will also be an additional bonus whereas he/she will be working in a quasi-supervisor role, which the department has been lacking for years.

The only downside is this will have a negative impact to the FY17/18 budget. However, the savings in "Person Services/Police", and "Overtime", will out-weigh the impact to the budget.
