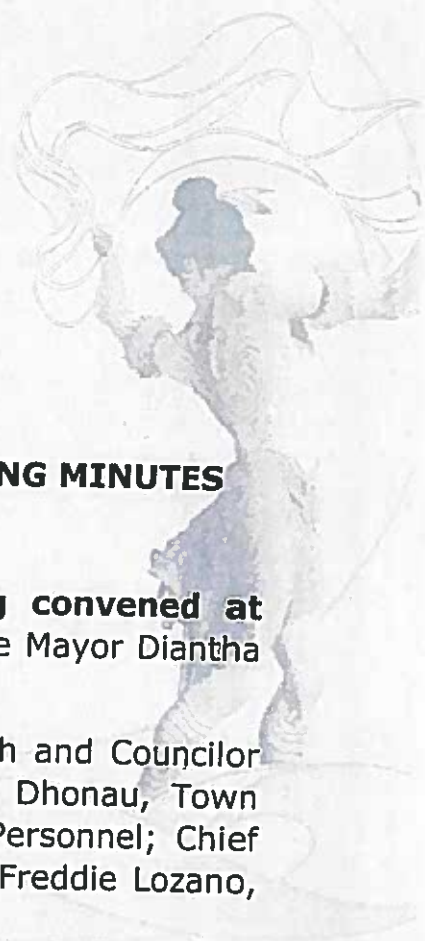

ADMINISTRATIVE AND FINANCE COMMITTEE MEETING MINUTES MINUTES - MARCH 6, 2018

The Administrative and Finance Committee meeting convened at 2:01 p.m. Those present were: Mayor Patrick Soranno, Vice Mayor Diantha Schear and Art Newsome, Citizen Member.

Also Present: Councilor Mike Petruccelli, Councilor Bill Smith and Councilor Mike Hackerson; Greg Yantorno, Building Official; Bonnie Dhonau, Town Administrator; Susan Scrogam, Director of Finance and Personnel; Chief Terry Hughes; Darlyn Stockfisch, Administrative Specialist, Freddie Lozano, and Ray DeCunto.

1.0 Consideration of approving the Administrative and Finance Committee Agenda for March 6, 2018.

Motion by Art Newsome – seconded by Vice Mayor Schear to approve the Committee Agenda for March 6, 2018. Motion carried 3-0.

2.0 Comments from the public on any Agenda Item.

There were no comments.

3.0 Recommendation to hire Freddie Lozano for the Town Clerk Position at an annual salary of \$53,590 to begin on Monday, March 26, 2018.

Susan Scrogam explained that there were 10 applicants for the open Town Clerk position and four were interviewed. The Interview Team unanimously agreed that Freddie Lozano had a skillset that was easily transferrable to the Town Clerk position.

Susan Scrogam said that she would help in training Freddie as she had her CMC (Certified Municipal Clerk) designation. She is also

making arrangements to have a local City Clerk mentor him during his learning process.

Bonnie Dhonau pointed out that Freddie came highly recommended by our Indian Shores Systems Administrator contractor, Tom Lancto.

Mayor Soranno opened up discussion for Public Comment.

Art Newsome mentioned that Freddie didn't appear to have any previous government experience.

Mayor Soranno replied that Freddie was switching careers from the private to the public sector.

Bonnie Dhonau added that Freddie had been in the process of changing careers as his company was recently bought out, and the staff had been warned about layoffs occurring within one year.

Councilor Hackerson stated concerns about Freddie's lack of government experience and that not being aware of pertinent state and federal laws (especially the Sunshine Law) would mean a steep learning curve. He thought our base salary for the Town Clerk position required that the candidate be qualified and having experience for the position. He suggested a more realistic base salary of \$45,000 and that salary could quickly climb based on Freddie's growth.

Freddie Lozano conveyed that he understood their concerns; however, he is confident in his ability, has great organizational skills and is a team player. He believes he can do the job at the level required and at the salary provided and is looking forward to growth into the CMC program.

Councilor Smith asked Freddie why he wanted the job.

Freddie Lozano replied that he had done some research on Indian Shores and was intrigued by what Indian Shores does for the Community (i.e., recreation classes, library and the educational presentations, etc.). He wanted to be a part of that community spirit.

Vice Mayor Schear inquired and got confirmation that Freddie would attend the June and October CMC conferences as a condition

of his employment. She also asked Freddie about any research he might have done on the laws of municipalities.

Freddie Lozano replied that he was reading up to get a head start on Chapter 119 (Public Records Law).

Vice Mayor Schear informed Freddie that he should not assume he knows something and to always ask if in doubt.

Larry Schear asked as to why some things were blacked out of Freddie's resume.

Bonnie Dhonau replied that the agenda packet is posted on our website, and we don't want to make personal information available to the public so that information was redacted.

Mayor Soranno said that it has been a challenge to get someone into this position as Indian Shores is a small municipality and the local candidate pool is small. We know what the job entails and the Interview Team has decided to move forward with hiring Freddie. Freddie will be fast-tracked through the CMC training, and he has the transferable skills needed and the technical background to take us forward. He recommended we hire him at the \$53,590 and work with him to make him a success.

Motion by Vice Mayor Schear – seconded by Art Newsome to recommend approving the hiring of Freddie Lozano for the Town Clerk position at an annual salary \$53,590 to begin on Monday, March 26, 2018. **Motion carried 3-0.**

4.0 Consideration of approving to hire Reservist Ray DeCunto part-time and change Major Smoak from full-time to part-time status.

Chief Hughes explained that when Major Smoak initially went full-time she made it clear that she didn't want to work full-time for long. She has been extremely instrumental in getting Chief Hughes caught up on various administrative aspects of the Police Department. She has now asked to go part-time to spend more time with her family.

Chief Hughes further explained that Ray DeCunto currently works as an Indian Shores reservist and has conducted some excellent training programs for the Town. Ray expressed an interest in

working part-time and this is a good opportunity to make that happen. He would be hired in at a rank of Captain, part-time at \$30 an hour with no benefits.

Ray DeCunto thanked the Committee for considering him for the part-time position. He currently has his own training company but wants to scale back on all the traveling he has to do. He had retired from the Sheriff's Office and has always stepped up for added responsibilities. He is very excited about this position.

Mayor Soranno responded that Ray has an impressive resume and comes highly recommended. Ray has been involved in the new Community Educational Programs that are part of the increased outreach our Police Department is involved in.

Motion by Art Newsome – seconded by Vice Mayor Schear to approve hiring Reservist Ray DeCunto part-time and changing Major Smoak from full-time to part-time status. **Motion carried 3-0.**

Mayor Soranno stated and the Committee concurred that Major Emily Smoak has done a terrific job for us and she would be missed.


5.0 Consideration of FY 2018/2019 Police Department Budget

Chief Hughes presented his proposed budget saying it needed to go before Redington Shores and then would come back to the Indian Shores Town Council for final approval on March 13, 2018.

Chief Hughes reported that he has been diligent in keeping costs down and gave examples in the agenda packet memo. He explained that he has had to raise personnel costs by hiring two additional officers that were needed and also in order to maintain qualified personnel. He further explained that there is an increase in the cost for the Sheriff's Office forensics involvement, but we are bringing in training for our officers on forensics which should ultimately help to lower those costs.

Motion by Diantha Schear – seconded by Art Newsome to recommend approval of the FY 2018/2019 Police Department Budget. **Motion carried 3-0.**

The Special Town Council meeting convened at 2:31 p.m. Those present were Mayor Patrick Soranno, Vice Mayor Diantha Schear, Councilor Mike Hackerson, Councilor Mike Petruccelli and Councilor Bill Smith.

Also Present: Bonnie Dhonau, Town Administrator; Susan Scrogam, Director of Finance and Personnel; Greg Yantorno, Building Official; Chief Terry Hughes; Darlyn Stockfish, Administrative Specialist; Art Newsome, Larry Schear, Ray DeCunto, Freddie Lozano and Rob Meador, Pinellas County.

1.0 Consideration of approving Special Town Council Agenda for March 6, 2018.

Motion by Councilor Smith – seconded by Vice Mayor Schear to approve the Committee Agenda for March 6, 2018. Motion carried 5-0.

Councilor Smith inquired as to whether Freddie Lozano would be trained by Elaine Jackson.

Bonnie Dhonau replied that Elaine was not available to help in training, but she had left a detailed binder with Town Clerk procedures and instructions.

Councilor Petruccelli asked if Stephanie Waters had her CMC.

Bonnie Dhonau replied that she got her CMC designation shortly after she took the position here as Town Clerk.

Bonnie Dhonau reported that she has reached out to Belleair Beach asking their City Clerk for some time helping in the training of Freddie.

Motion by Vice Mayor Schear – seconded by Councilor Smith to approve the hiring of Freddie Lozano for the Town Clerk Position at an annual salary of \$53,590 to begin on Monday, March 26, 2018. **Motion carried 4-1 (Councilor Petruccelli opposed).**

4.0 Consideration of approving to hire Reservist Ray DeCunto part-time and change Major Smoak from full-time to part-time status.

There was no further discussion.

Motion by Councilor Smith – seconded by Councilor Hackerson to approve the hiring of Reservist Ray DeCunto part-time and change Major Smoak from full-time to part-time status. Ray DeCunto would be hired in at a rank of Captain, part-time at \$30 an hour with no benefits. **Motion carried 5-0.**

5.0 Presentation by Rob Meador, P.E., Pinellas County Public Works, of proposed ITS Electronic Signs on Gulf Boulevard.

Rob Meador, P.E., handed out an overview of the proposed ITS (Intelligent Transportation Systems) and how it would work in conjunction with the ATMS (Advanced Traffic Management Systems) which is planned to improve transportation safety and mobility using a broad range of wireless and wire line communications-based information and electronic technologies.

Both systems used together will allow motorists to be notified of incidents, evacuations, bridge closures, alerts, safety messages and travel time that would improve the flow of vehicle traffic and improve safety.

The result for Indian Shores would be the installation of two electronic signs and cameras on Gulf Boulevard on the North side of Town and then here on Gulf Boulevard where the current sign is that notifies of the upcoming Park Boulevard Bridge.

Vice Mayor Schear relayed that she was not in favor of another sign in Indian Shores. There are only two ways you can go on Gulf Boulevard so if traffic is backed up, there really is no alternative route.

Rob Meador relayed that besides what has already been installed in Pinellas County, there are additional signs/cameras planned for Redington Beach, Madeira Beach and Treasure Island. Indian Rocks Beach did not want the signage and St. Pete Beach does not want the signage but does want the cameras.

Rob Meador understands the concerns that the signs need to be as appealing as possible and pointed out the added artistic figurine examples in the handout. He reiterated that their focus is on safe transportation modes and these signs would be a major asset for the 911 police and fire response.

Mayor Soranno conveyed that he did not have a good feeling about the huge sign designated for out front. He thinks we need to evaluate the project more and take into consideration why some of the other Towns voted against it.

Councilor Petruccelli thanked Rob for his very clear and concise presentation and thought it was a worthwhile project.

Bonnie Dhonau instructed that this is just an overview and that it would be back before Council on the March 13 meeting agenda for a vote.

Mayor Soranno would like us to highly publicize the meeting where this topic would be addressed and asked that Rob provide an example of what the proposed Indian Shores signs would look like as compared

to the existing signs. He also requested a one-page overview of the project and its impact for that meeting.

Councilor Hackerson thought that the Indian Shores property owners really didn't know about this proposed project and emphasized getting the Community notified and getting their comments prior to deciding.

Chief Hughes asked about the possibility of putting our Indian Shores branding on the sign.

The Council consensus was to get this information out at an upcoming public meeting.

6.0 Citizens Comments on any subject.

Art Newsome agreed that most of the residents probably did not know about the Pinellas County proposed signage.

Larry Schear asked if there were any other meetings besides the Big-C meeting that gave an opportunity to get public input on this topic.

7.0 Mayor's and Council Members comments on any subject.

Councilor Hackerson stated that the Gulf Boulevard Beautification project is down to a punch list of items to be done and will be completed by the St. Patrick's Day Festival.

Mike Petruccelli reported that there were still some open volunteer slots that needed to be filled for the St. Patrick's Day Festival.

Councilor Smith informed that the Arts Council had hit a snag with the Monument Call to Artists and is bringing in Anne Wykell to help assist with the issues. He also thanked Councilor Hackerson for having the Tiki Gardens site cleared for placement of the monument.

Mayor Soranno relayed that he has been involved in meetings that have allowed him to meet the candidates running for local Districts 66 and 69 and has been able to ask these candidates specifically for their endorsement of Home Rule.

Mayor Soranno instructed the Council that the next meeting would include electing a new Vice Mayor and other Committee appointments, and if anyone was interested in being involved, please let Bonnie Dhonau know.

Council talked about possibly having the Swearing in Ceremony at the March 13, 2018, meeting if possible.

Meeting adjourned at 3:34 p.m.

PROBLEM GAMBLING AWARENESS MONTH

WHEREAS, The Town of Indian Shores has recognized March 2018 as Problem Gambling Awareness Month to demonstrate its support in addressing problem gambling and the initiative of the Florida Council on Compulsive Gambling in bringing awareness to the issues surrounding problem gambling in our community; and

WHEREAS, problem gambling is a serious public health issue which impacts family, friends, and businesses with significant societal and economic costs, affecting more than one million Floridians of all ages, races, and ethnic backgrounds in all communities; and

WHEREAS, it is estimated that more than 6 million people of every age, race, ethnicity, and socio-economic status suffer from problem gambling and need treatment; and

WHEREAS, the issue of problem gambling is a community issue, as 8-10 people are affected for every one problem gambler and conservative estimated social costs are \$7 Billion annually; and

WHEREAS, educating the public about how problem gambling affects everyone in the community, including youth, older adults, and families, is essential if we are to be proactive about this problem; and

WHEREAS, the Florida Council on Compulsive Gambling's 2018 **Shine the Light on Problem Gambling-The Hidden Addiction** awareness campaign provides an opportunity for the public, policymakers, educators, businesses, mental health, criminal justice professionals, the gaming industry, and others, to make known the adverse effects of problem gambling, as well as available treatment; and

WHEREAS, any individual, professional, or organization whom is dedicated to assisting those in need can participate in raising awareness and treating problem gambling by promoting the statewide 24-hour HelpLine, 888-Admit-It.

NOW, THEREFORE, I, Mayor Patrick Soranno, of the Town of Indian Shores, do hereby proclaim the month of March 2018 as Problem Gambling Awareness Month.

Since 1988, the **Florida Council on Compulsive Gambling, Inc. (FCCG)** has been fulfilling its primary mission to increase public awareness about gambling addiction and to furnish support to persons in need of assistance. The month of March is nationally recognized as **Problem Gambling Awareness Month (PGAM)**. The prevalence of problem gambling is estimated at 1%-3% of the population. That equates to hundreds of thousands of Floridians and more than 6 million people in the United States. The social impacts exceed \$7 Billion annually, and for every problem gambler, 8-10 people are negatively affected (spouses, parents, children, friends, employers, etc.). One of the most alarming facts about problem gambling is that of all other addictions, it has the highest rate of suicide.

The FCCG would like to request you proclaim March 2018 as Problem Gambling Awareness Month in The City of Indian Shores to help bring public awareness not only to problem gambling, but also awareness of the help, resources, and treatment available through the FCCG to anyone negatively affected.

By making this proclamation in your city, you will join the FCCG, many individuals, municipalities, organizations, and agencies across the state of Florida in helping to raise public awareness about the effects of problem gambling; signs of the disorder, what treatment options are available, for those who seek help.

The theme for this year's PGAM is "Shine the Light on Problem Gambling – The Hidden Addiction". Problem Gambling is often called "The Hidden Addiction" as the signs are not as visible as they are with a substance abuse problem. While visible symptoms are minimal, problem gamblers are often depressed, anxious, and may have suicidal thoughts. They often neglect family and friends, run up large amounts of debt, and may be involved in illegal activity in order to fund their gambling addiction.

Last year, the Florida Council on Compulsive Gambling received mayoral proclamations from nearly 60 cities throughout the State of Florida. We would like to surpass this number in 2018, and will do our best to personally attend as many declaration events as possible. However, we ask that in addition to your sending us the official declaration, if you have photographs of the mayor's presentation and/or announcement of this proclamation, please send to PGAM@gamblinghelp.org so we can acknowledge your support on our website.

Please join us in bringing awareness to this important public health concern by issuing a proclamation and formally recognizing Problem Gambling Awareness Month for your city during the month of March 2018. 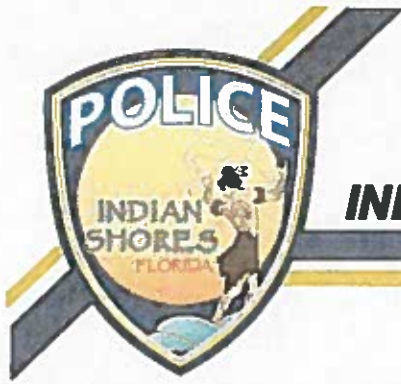

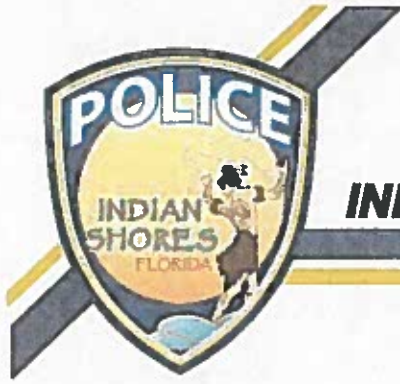
Mayor Soranno,
