4.0 **PUBLIC HEARING**: Quasi-Judicial

Consideration for recommendation of a Site Plan review request from The Town of Indian Shores to develop a Monument Project located at the Northwest corner of the Tiki Gardens Parking area, 19601 Gulf Boulevard, Indian Shores, FL 33785. (S24, T30S, R18E) Parcel # 24-30-14-42912-006-0030. The project will consist of a new sculpture with arch, interpretive signage, circular plaza, lighting, landscape and irrigation.

Dr. Rinker read the Quasi-Judicial announcement.

Mr. Lozano administered the Oath to Mr. Mazzei, Mr. Dabkowski, and Mr. Powell who wished to testify in the hearing.

Mr. Dabkowski updated the Board on each of the open items in his letter of recommendation. The items included a legal description discrepancy, no high-water line on the plans, stormwater management plan, electrical engineering plan, and a completed Storm Water Pollution Prevention Plan (SWPP).

He spoke with Celia Nichols of Nichols Landscape and Architecture, Inc., who assured him that the high-water line will be on the plans that the surveyor will sign and seal. This does not impact the project.

Every item on the list was resolved and/or addressed. He is comfortable with the structural design and thinks that the finished product will meet all the Town's expectations.

Mr. Mazzei mentioned having conversations with the contract signing company regarding the building's velocity zone standard requirements with regards to the Town's floodplain ordinance and higher standards, which will be addressed by the engineer when the building permit plans are submitted. He did not see any issues with the site plan and commented that it is a very good project.

Mr. Powell commented that this project has been in the works for many years and that the plans have been reviewed many times. The contractor is confident that this will be a spectacular project and is excited to get started. The project is anticipated to begin as early as next week if the site plan is approved and when permits are issued. It will be a multiphased project with the plaza, arch, landscaping and irrigation expected to be completed in the first quarter of 2022. The bronze statue is slated for July 2022.

Mr. Housman questioned what possible impacts the project could have to the sidewalk in the northeastern corner and the type of materials being used to construct the monument arch.

Mr. Powell replied that a portion of the sidewalk will be demolished, and several new sidewalks will be installed that will connect to Gulf Blvd. and to the monument plaza. The arch will be constructed with aluminum with stainless steel fasteners and anchors. The fossil panels will be made of very durable DHPL (Digital High-Pressure Laminate) panels that have decades of life.

Motion by **Mr. Housman** – seconded by **Ms. Riva** to approve the recommendation of the Monument Project site plan located at the Northwest corner of the Tiki Gardens Parking area, 19601 Gulf Boulevard, Indian Shores, FL 33785. (S24, T30S, R18E) Parcel # 24-30-14-42912-006-0030, as presented. **All ayes. Motion carried 3-0.**
